Dear Ms. Howard:

In or about 1986, I was forced to flee from my home in Columbia with my daughter to Myrtle Beach due to my violent spouse. I worked at the area ^{FLEA} markets to support us. My husband, a paid FBI informant assaulted me at Surfside flea market, had me arrested, kidnaped our daughter, whom I had legal custody of. I was released from jail due to attorney Paul Joseph's intervention.

I began searching for my daughter, after 11 months I discovered that my husband's attorney, Bobby Howe, had persuaded Judge Dave Waring to give my husband custody without notifying me, beginning a vicious custody battle when I was finally given visitation until a divorce hearing. In November 1989/1990, I informed my husband that I would be late returning daughter; he, then supposedly with his FBI funds hired an attorney who supposedly contacted Judge Dean who issued an ex parte order to remove daughter from my house even if the Horry County Police had to 'kick my door down', without a hearing. My then current husband & I had gone to great lengths to

never allow my self to know where we lived because of his violence, however, due to Judge Hearn's order he now knew where we lived, a short time later, my husband, John Sarris was murdered!! upon information & belief by Clifford Hubbard.

In March of this year, I contacted a local attorney who had represented me after being assaulted by my self re: 'How the FBI helped finance the kidnaping of my daughter', also how Judge Hearn's order which allowed Hubbard to learn of my residence ultimately led to my husband's death, I inquired of Joe McCullough re: the possibility of filing a lawsuit against the Navy County Police Department for bringing Hubbard to my house causing the wrongful death of my husband. Judge Hearn should have recused herself before deciding my fate in this Court!!

As an ignorant layman of the law, I did my best to respond to the explanation ^{re:} SCAER(C) with sufficient facts stating unique circumstances warranting review of lower courts PCR dismissal & presented evidence that I am actually innocent of murder, that my trial was a farce, my attorney (Theresa Johns), the Solicitor, Ralph Wilson & possibly the trial judge (Sidney Floyd) were all in collusion to convict me of murder because of their personal relationships with former Solicitor,

Jim Dunn, a former lover of mine, who was aware that at anytime I could possibly 'blow the whistle' on the corrupt beginning of his career which he began & ended corruptly! Upon information & belief they are all friends & colleagues of Judge Dean.

The rules of Court are very important, however, PCR remedy Chapter ^{25:9} ~~25:9~~ should override any mistake made by pro se defendant who proved with pertinent parts of her trial transcripts that she is actually innocent of murder which this Court and the lower court overlooked, not shocking to me as I have been in this corrupt system since the age of 13, so it is no surprise that I will be forced to end my earthly course in prison which is why I filed re: relief in my last PCR(2019), in the attempt for a lethal injection which was ignored by the Courts which use arbitrary procedural matters rather than the Truth!
