1. The judge that did my plea was ineffective by know the younger vitum and her family which is a conflict of interest.
2. My counsel coerced my plea by pressuring me into pleading. Redmond v. Kingston 240 F.3d 590; Doswell v. City of Pittsburgh F. SUP 2d 2007 WL 2907886 and Ostrander v. Green 46 F.3d 347
3. The judge who did my plea hearing violated South Carolina Rules of Court Rules of the Common Plea which says any time a defendant pleads not guilty or says he did not do it the plea must be true.
4. The prosecutor made improper remarks by saying my crime was a hate crime when it was not. Darden v. Wainwright 477 U.S. 168, 181; U.S. v. Carela 805 F.3d 374, 382-83, and U.S. v. Plascencia-Orozco 852 F.3d 910, 926-27
5. The detective for the Clenden County Sheriff's Department coerced my plea by threatening to use coerced confession at my plea when I told the judge that I did not rape these women.

7. My Post Conviction Relief judge

Habeas corpus were ineffective in  
dismissing my appeal saying that I  
was under oath when I pled guilty

I told the judge I did not rape these

## History of case

In July of 2006 ME and codependant took 2 black women to my trialure had sex with them we took them to my trialure a week apart. My codependant said to kill the younger one so I stabbed her. the wounds were very minor. In fact she did not do anything but get a few stitches and go home. The only reason I did it is to keep my codependant from killing her. I even lied to him when he told me to check her pulse. And told him that she was dead.
