We did that in PEBA's Designation of Matter.

In addition, with respect to the prescription medication records and physician records that you have identified in your Designation of Matter, please identify the specific pages from the ALC Record on Appeal where each of those documents are located. As set forth in the South Carolina Appellate Court Rules and the jurisprudence of the South Carolina appellate courts, documents/evidence not included in the record before the lower court (the ALC) cannot be considered by the Court of Appeals; therefore, such documents should not be included in your Designation of Matter. We will oppose the inclusion of any such documents in the Record on Appeal.
