MOTION TO DISMISS APPEAL
AND MEMORANDUM IN SUPPORT

Respondent moves, pursuant to Rules 203, 240 and 262, South Carolina Appellate Court Rules, for an order of this Court dismissing any appeal in the above captioned matter. This motion is made with the consent of opposing counsel. The motion is based on the fact that Appellant failed to serve any notice of appeal upon Respondent within thirty (30) days of written notice of the entry of the order and judgment of the lower court which Appellant purports to appeal.

Respondent served Appellant with a copy of the lower court's order denying Appellant's motion for reconsideration on April 21, 2022. (See Exhibit 2, Affidavit of Kyle B. Parker attached hereto and made a part hereof). Appellant has filed a notice of appeal with this Court in which he represents to have received notice of the order and judgment appealed from more than thirty (30) days from the date of the instant motion. (Notice of

Appeal). As of the date hereof, Appellant has not served any notice of appeal on Respondent as required by Rule 203, South Carolina Appellate Court Rules. (Affidavit of Kyle B. Parker).

Rule 203, South Carolina Appellate Court Rules, requires an appellant to serve the notice of appeal on all respondents “within thirty (30) after written notice of entry of the order or judgment.” “The requirement of service of the notice of appeal is jurisdictional, *i.e.*, if a party misses the deadline, the appellate court lacks jurisdiction to consider the appeal and has no authority or discretion to ‘rescue’ the delinquent party by extending or ignoring the deadline for service of the notice.” USAA Prop. & Cas. Ins. Co. v. Clegg, 377 S.C. 643, 651, 661 S.E.2d 791, 795 (2008). An appellant's failure to serve notice of appeal within 30 days after receiving written notice of the entry of a final order or judgment divests the appellate court of subject-matter jurisdiction and results in the dismissal of the appeal. Id.

Here, Appellant seeks appeal of an order denying his motion made pursuant to Rule 59, South Carolina Rules of Civil Procedure. Therefore, a notice of appeal must be served within thirty (30) days of Appellant’s notice of the entry of the lower court’s order. Appellant has failed to serve the notice of appeal on Respondent within such time as required by Rule 203, South Carolina Appellate Court Rules. As a result, this Court lacks jurisdiction and must dismiss the appeal. Id.

CONCLUSION

For the reasons set forth above, Respondent respectfully requests the Court dismiss the appeal with prejudice.

A copy of the letter is attached hereto as Exhibit 1 and made a part hereof.


3. That he served a copy of the order of the lower court denying Mr. Perry's



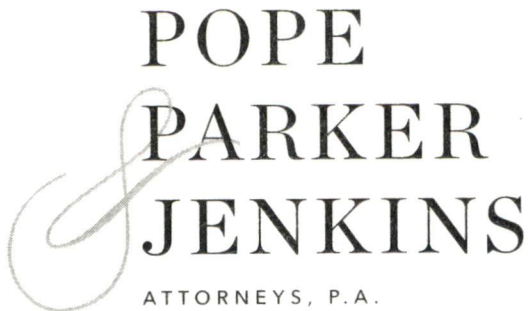
